## Nottingham Business School

### *Visiting Scholar Scheme*



Applications are invited from established academics in overseas universities wishing to spend all or part of their sabbatical leave periods working at Nottingham Business School. The scheme is open to scholars researching in any academic area covered by the four academic Departments which comprise the Business School - Accounting, Finance and Business Information Systems, Human Resource Management and Strategic Management and Marketing.

Prospective visiting scholars are strongly encouraged to identify a colleague(s) at NBS with whom they would wish to work, preferably with a view to producing joint research publications. The application form should be completed and returned to the Research Co-ordinator, Nottingham Business School, Nottingham Trent University, Burton Street, Nottingham, NG1 4BU at least two months before the intended period of visit is due to begin.

Scholars can visit for any period of time up to one year. Normally there would be no more than two visiting scholars at any period in time.

#### **NBS Facilities**

Visiting scholars will be provided with desk space in the part-time lecturer's room, access to a computer, use of the Boots University Library and use of post, fax and phone facilities. The School, with the assistance of the University's Accommodation Service and informal contacts, will assist in helping to find rented accommodation in and around Nottingham (but the cost of this would be the responsibility of the scholar).

No salary will be paid to visiting scholars, but it may be possible to organise paid part-time teaching up to a maximum of six hours per week.

#### **About Nottingham Business School**

##### ***Location***

Nottingham Business School is one of nine faculties within The Nottingham Trent University. Located on the City Campus, the Business School has around 150 academic staff and support staff dedicated to the University's work in management, business and accounting education.

##### ***Structure***

The School has adopted a matrix structure within four academic departments, two programme areas, a Research Office and associated administrative support teams.

The academic departments are the focus for *departmental initiatives* in course and curriculum development, and for research and most staff development. The departments provide the academic staffing base of the School.

The two programme areas (Postgraduate and Professional; Undergraduate) are responsible for the faculty-wide strategic development of the programmes, and the routing operation of individual courses. The School's Research Office operates in a similar way - devising, facilitating and monitoring faculty-wide initiatives, including liaison with external sponsors and clients.

The academic work of the School is enhanced by designated support teams who, working with academic staff, ensure that the School's human and physical resources meet the needs of students, employers and other clients.

### ***Mission***

The School's mission is dominated by five main themes that reflect our thinking about the nature of the educational services we provide individuals and organisations; the themes also inform the School's long-term objectives and strategy.

In summary, our mission is to provide clients with educational services that are

- *excellent*
- *innovative*
- *accessible*
- *flexible*
- *undertaken in partnership*

In 1994, following a three-day quality assessment visit by HEFCE, the School's provision was seen as a demonstration of our commitment to our mission, and judged to be 'excellent' by the Funding Council. In the 1996 Research Assessment Exercise, the School's research was rated 3a, the highest award given to any 'new' university in the Business and Management Unit of Assessment.

### ***Context***

NBS is accountable for the majority of the management, business and accounting education offered by the University. With nearly 4,000 students enrolled on courses managed by the School, NBS is a significant national provider of full-time and sandwich students.

Within its total enrolments the School has almost 2,000 part-time students. Many of these continue to attend 'open' courses offered in Nottingham; courses, such as the CM, DMS and MBA. Increasingly, however, different modes of attendance have become attractive to students and courses are offered for weekend attendance, over a three or four day residential period and in-company. An important and growing part of our portfolio is the number of postgraduate courses offered in partnerships with major companies like McDonald's, TSB and the Leisure and Brewers divisions of Bass Plc. In line with the School's mission, these courses are designed in partnerships with our clients, provide access to a Higher Degree, and are often delivered off-campus.
